



MOTHER'S DAY COMPETITION - IN THE KITCHEN WITH MUM

With the Mother's Day Competition, we invite you to take part in our 'In the Kitchen with Mum' challenge by submitting your creative entry on the Competition Page during the 7-day competition period. Quick recap on how it works:

4. This competition is in no way sponsored, endorsed or administered by, or associated with, Facebook. Entrants understand that they are providing their information to the promoter and not to Facebook. Any questions, comments or complaints regarding the competition must be directed to the promoter and not to Facebook. The information an entrant provides will only be used in the ways outlined in these terms and conditions. 13. The 5 most creative entries, as judged by the promoter, will win one (1x) prize each (5x prizes total). As a game of skill, entries will be judged solely on creative merit. Chance plays no part in determining the winners. Any entry not including a creative response shall be deemed invalid.
